Legislative Day 36 & Recess

The General Assembly convened on Monday March 19, 2018 for Legislative Day 36 and remained in recess on Tuesday, March 20 for the purpose of a committee work day. With few days remaining in the 2018 legislative session, both chambers have held long floor sessions and committees are working to move out their final bills of the year. The Senate Appropriations Committee is set to hear HB 684, the FY 2019 budget, on Wednesday morning.

The House and Senate will return Wednesday, March 21 for LD 37 and Friday, March 23 for LD 38. Both chambers will stand in recess for the final committee work day on Thursday, March 22.

HB 381 - Abandoned Mobile Home Act; enact

Sponsor: Rep. John Corbett (R – Lake Park)

Action: HB 381 passed the Senate by Substitute with a vote of 53-0. (3/19/18)

HB 410 - Condominiums; certain fees imposed on purchasers; provide for limits

HB 790 - State government; recommendations of the Court Reform Council; implement

HB 891 - Handicapped persons; blind persons shall not be discriminated against in matters relating to child custody; provisions

Sponsor: Rep. Carl Gilliard (D – Garden City)

Action: HB 891 was given a hearing by the House Judiciary Civil Kelley Subcommittee.

HB 897 - Georgia Power of Attorney Act; revise

Sponsor: Rep. Chuck Efstration (R – Dacula)

Action: HB 897 passed the Senate with a vote of 53-0. (3/19/18)

HB 906 - Public records; public disclosure of personal information of certain foster parents;

HR 993 - Business court; state-wide jurisdiction; create

HR 1416 - House Study Committee on Bail Reform; create

SB 39 - Pimping and Pandering; increase the penalty provisions

SB 127 - Failure to Provide Notice Not Rendering Responsible Person Liable; victim to file a motion in a criminal case to assert his or her rights; allow

SB 301 - "Revised Uniform Fiduciary Access to Digital Assets Act"; enact

Action: SB 301 passed the House with a vote of 162-2. (3/19/18)

SB 315 - Computer Crimes; create a new crime of unauthorized computer access; penalties;

provide

Action: No action was taken on SB 315 by the House Judiciary Non-Civil Committee. (3/20/18)

SB 335 - Trafficking of Persons for Labor; offense of trafficking an individual for sexual servitude; expand
