Legislative Day 30 & Recess

The General Assembly returned to the Capitol on Monday, March 6 for Legislative Day 30 and was in recess on Tuesday, March 7. Only nine legislative days remain before Sine Die and the rest of the adjournment resolution designates non-legislative days as "committee work days." While the FY 2019 budget has not yet been passed by the House, Senate Appropriations subcommittees are holding hearings this week.

The House and Senate will convene on Wednesday, March 7 (LD 31) and Friday, March 9 (LD 32), with a number of committee meetings scheduled to take place on Thursday, March 8.

#### Floor and Committee Action

### **Legislation Supported by the Judicial Council**

HB 162 - Income tax; transfer of setoffs by the Administrative Office of the Courts; revise procedures

Sponsor: Rep. Betty Price (R – Roswell)

**Action:** HB 162 passed the Senate by Substitute with a vote of 53-0. (3/5/18)

SB 407 - Criminal Justice System; comprehensive reform for offenders; provide (LC 29 7957S)

Sponsor: Sen. Brian Strickland (R – McDonough)

**Action:** SB 407 received a hearing from the Senate Judiciary Committee. (3/5/18)

SB 436 - Probate Courts; general provisions; change and modernize

Sponsor: Sen. Brian Strickland (R – McDonough)

Action: SB 436 received a Do Pass by Committee Substitute from the House Judiciary Civil

Fleming Subcommittee. (3/6/18)

HB 571 - Magistrates Retirement Fund; member in arrears for dues payments for 90 days shall be suspended; provisions

Sponsor: Rep. Sam Watson (R – Moultrie)

Action: HB 571 received a Do Pass from the Senate Retirement Committee. (3/6/18).

<u>HB 79 - Motor Vehicles; criminal offense and minimum fines for improper operation of an</u> authorized emergency or law enforcement vehicle; provide

HB 137 - Crimes and offenses; restrictions on contingency fee compensation of an attorney appointed in forfeiture actions; change provisions (LC 29 7616S)

**Action:** HB 137 received a Do Pass by Substitute as amended by the Senate Judiciary

HB 381 - Abandoned Mobile Home Act; enact (LC 39 1819ERS)

**Action:** No action was taken on HB 381 by the Senate Judiciary Committee. (3/5/18)

<u>HB 668 - Guardian and ward; petitions for appointment of a guardian under certain</u> circumstances; provisions

**Action:** HB 668 received a Do Pass from the Senate Judiciary Committee. (3/5/18)

## <u>HB 670 - Georgia State Council for Interstate Juvenile Supervision; number of legislative branch</u> representatives; revise

Sponsor: Rep. Alan Powell (R – Hartwell)

Action: HB 670 received a Do Pass from the Senate Judiciary Committee. (3/5/18)

#### HB 683 – Supplemental appropriations; State Fiscal Year July 1, 2017 - June 30, 2018

Sponsor: Speaker David Ralston (R – Blue Ridge)

**Action:** The Senate Agreed to the House Amendment to the Senate Substitute to HB 683. (3/5/18)

#### HB 808 - Courts; term of court in certain counties in the Waycross Circuit; change

Sponsor: Rep. Chad Nimmer (R – Blackshear)

Action: HB 808 received a Do Pass from the Senate Judiciary Committee. (3/5/18)

#### HB 897 - Georgia Power of Attorney Act; revise (LC 29 7837ER)

Action: HB 897 received a hearing from the Senate Judiciary Committee.

## HB 907 - Public officers and employees; appointment and election of successor in event of vacancy in the office of district attorney; provide

## SB 194 - Garnishment Proceedings; maximum part of disposable earnings subject to garnishment; change (LC 29 7744ERS)

Action: SB 194 received a Do Pass by Substitute from the House Judiciary Civil Fleming

Subcommittee. (3/5/18)

### SB 301 - "Revised Uniform Fiduciary Access to Digital Assets Act"; enact

**Action:** SB 301 received a Do Pass from the House Judiciary Civil Kelley Subcommittee (3/5/18); and, received a Do Pass from the House Judiciary Civil Committee (3/6/18).

### SB 321 - Medicaid Claims; false or fraudulent; recover the maximum penalty authorized by federal law; increase the civil penalties (other)

**Action:** SB 321 received a Do Pass from the House Judiciary Civil Kelley Subcommittee (3/5/18); and, received a Do Pass by Substitute from the House Judiciary Civil Committee (3/6/18).

SB 431 - Liability Not Limited; effect of an owner of land charging an admission price or fee; provisions; clarify
