

Why MCS became a Charter System

- Previous discussion with legislators
- Flexibility from rules
- Provide additional funds to innovate
- SB 39
 - It is the intent of the General Assembly to increase student achievement through academic and organizational innovation by encouraging local school systems to utilize the flexibility of a performancebased contract called a charter (O.C.G.A. §20-2-2061)

Why MCS became a Charter System

- Consistent with vision, mission, strategic plan
- Potential federal and state revenue
- Previous History
 - Elementary Imagine Start-up
 - Elementary Conversion Charter

- May 20, 2008: SBOE considers and approves only Warren County, tables other three until June
- June 12, 2008: SBOE approves Marietta City Schools as one of Georgia's first four Charter Systems

- Teacher tenure, Fair Dismissal, Salaries

 - A Charter System not a System of Charter Schools



The Plan/Petition – Key Elements

- Student Achievement
 - Exceeding Standards
- Board approved what is stated in the petition with understanding that they would approve anything not explicitly waived
- Did not waive
 - Tenure, Fair Dismissal
- How to:
 - Support innovation and our strategic plan
 - Deal with personnel, principal evaluation
 - Maximize school governance



The Plan/Petition – Key Elements

- The MCS Charter System does not include either of the system's two existing charter schools
 - Marietta Imagine Charter School (Start-up charter)
 - Sawyer Road Elementary (Conversion charter)
- For reporting and grant funding purposes, Magnet school not considered part of charter system due to entrance criteria



Maximize School Governance – How?

School-level governance is defined as decision-making authority in personnel decisions, financial decisions, curriculum and instruction, resource allocation, establishment and monitoring of school improvement goals, and school operations




Maximize School Governance – How?

- Local school council served as the framework of an expanded governance board known as the School Governance Team (SGT)
- **Developed bylaws** governing the composition, authority, and processes of the School Governance Team (SGT)

Maximize School Governance – How?

Learning process ongoing

- Areas for decision-making, advisory & recommendation
- Recommendations to the Board
 - School-based and system (e.g., school calendar, policies)
- Training (key) developed modules
 - How to function as a highly effective Board, Budgeting, Measurement and Assessment, Special Education, Human Resources, other as requested



School Governance

- Timeline for implementation of annual actions and training
- Bi-annual meeting with Superintendent and Staff (monitor/evaluate processes, progress towards goals, concerns, share best practices among schools
 - Concerns time, parent participation, focus on School Improvement Plan (SIP)
- Dispute resolution process
- Tools: Web site, e-mail, brochures, video, handbook, surveys, co-branded logo

What it Means to be a Georgia Charter System brochure

Overview

Marietta City Schools (MCS) became one of Georgia's first Charter Systems in June 2008. The MCS charter system includes ten schools: six K-5 elementary schools, one sixth grade academy, one middle school, one high school, and one grades 3-5 elementary magnet school (Marietta Center for Advanced Academics). The MCS charter system does not include either of the system's two existing charter schools, Marietta Charter School (start-up) and Sawyer Road Elementary (conversion).

MCS also has an alternative program for grades 9-12 at the Marietta Performance Learning Center at Woods-Wilkins. This program is not listed as a "school" to be converted under the charter system. The school district also includes two SB 618 residential treatment centers: George W. Hartmann Center and Nelson Price Treatment Center. These residential treatment centers operate under Memorandums of Understanding with MCS and the Georgia Department of Education.

School Choice

Through a strategic planning process begun in 2006, MCS has already implemented certain system-wide innovations. One of these is elementary school choice (<u>'Choice</u> <u>Academies</u>). Curriculum at our elementary schools is based on the Georgia Performance Standards (GPS), and enhanced by school-selected focuses:

The Board of Education of the City of Marietta believes parent and community support is critical to the success of students and schools. The establishment of School Governance Teams (SGT), pursuant to the Marietta City Schools Charter System petition, is intended to help local boards of education develop and nutrure participation, bring parents and the community together with teachers and school administrators to create a better understanding of and mutual respect for each other's concerns, and share ideas for school improvement.

Marietta City Charter System schools use the local school council as the framework of an expanded governance Board referred to as the School Governance Team (SGT). The SGT is entrusted with the responsibility of providing input, making recommendations, and rendering decisions regarding various aspects of the instructional program of the school and the school's operational scheme. So TS replace existing School Councils at all schools, with the exception of Sawyer Road Elementary, currently a conversion charter school.

As is required by the Constitution of the State of Georgia, the management and control of public schools shall be the responsibility of the local board of education.







Marietta City Schools (MCS) A Georgia Charter System - Handbook







 Charter System status positions the district to potentially capture charter grant funds, and other funds, that will enable schools to purchase technological tools and instructional resources to improve student achievement



Planning Grant

- \$5,000 (Dec. 2007)
- State Charter Implementation Grants
 - \$125,000 to SGTs

Federal Charter Implementation Grants

Not received



Additional QBE funding

- HB 881 amended O.C.G.A. 20-2-165.1 to "earn 3.785 percent of the base amount established pursuant to subsection (a) of Code section 20-2-161 for each full-time equivalent student in each school within the charter system"
 - SGTs determine use for innovation tied to school improvement plans
- Flexibility in use of existing and reduced Marietta resources/funds

 The ability to develop programming unrestricted by the parameters of state rules and regulations provides our schools with increased capacity to offer valuable learning experiences



Impacting Students A Charter System not a System of Charter Schools

- Ability to implement segments that are not constrained by artificial time and space barriers
- Flex time for staff to meet needs of students
- Ability to create flexible groupings that allow us to target remediation and enhance activities without the constraint of funding floors and maximum class size



- Supports Choice Academies, IB-MYP, STEM = Innovation
- Middle School Funding
 - Middles grades vs. middles school funding
- Alternative Education Program Waivers
- Required Seat Time Waivers
 - Reduced HS seat time to accommodate advisement period

- Calendar Flexibility
 - Instructional days reduced (180 to 178 days)
- Class Size Waivers
 - +2 above local/state maximums, system averaging
- Flex grouping of students
 - W/out max class size concerns

Impacting Students

64% F/R, 45% African American, 30% Hispanic, 19% white

- 48.3% of MCS students (Grades 3-8) exceeded standards in at least one area of the 2010 CRCT
 - Strong reduction in Level 1 students
- Graduation rate 80.5%
- Title I Distinguished District
- All schools and system made 2010 AYP on first release
- Parent satisfaction survey
 - Increase from 81% to 89%
