Course Names and Numbering for Students Assessed by the GAA (Georgia Alternate Assessment)

Students assessed by GAA will continue to receive instruction in the high school courses at the access level, but the courses will no longer be called "Access to...." on transcripts. The courses will have the same name as the general education courses. The documentation that a student is to be assessed by the GAA will be the GAA flag in FTE. The GAA flag designates that the student is receiving instruction at an access level.

An 8 as the first numerical digit to the right of the decimal indicates that the student's Individualized Education Program (IEP) has placed them in a general education course but in a special education setting and the student is being taught by a certified special education teacher. Students in these classes are earning Carnegie unit credit.

A 9 as the first numerical digit to the right of the decimal indicates that the student's Individualized Education Program (IEP) has placed the student in a general education course in a general education setting but with a specified amount and model of special education support listed on the IEP. Students are taught by a certified general education teacher and also receive the identified IEP support by the appropriately certified special education personnel. Students in these classes are earning Carnegie unit credit.

Any course may be reported with a XX.8 and a XX.9. If a course number contains a XX.8 or XX.9 and the student is also participating in the GAA, then the student's instruction "aligns" with the standards for this course. The standards will not be addressed with the same depth and breadth as they will be for other students, and the IEP will address other instructional needs as well.

As indicated in the new board rule, the 5 in the fourth digit after the decimal is no longer used.

Two important things to remember:

- 1. The XX.8 and XX.9 course number does not distinguish between a high functioning student with a disability who is addressing all standards at the same "depth and breadth" as all other students and a student with a significant cognitive disability participating in the GAA. It is the GAA flag that is the indicator of the level at which the standards will be addressed, not the course number.
- 2. The XX.8 and XX.9 course numbers should not appear on transcripts. That is also in the board rule and I have copied that into the email.

Page 6 discusses the courses for students assessed by GAA. .The graduation rule allows an IEP to determine if a student must have more than 3 math courses. For students on GAA, the IEP team can determine if they need access to another math course. (Students on GAA do not take Math Support classes because of the significant modifications at the access level.) For all other courses, the number of required courses should mirror the requirements of general education students to receive a diploma.

ACCEL and Move on When Ready (MOWR)

The purpose of this communication is to provide clarification regarding the coding of postsecondary courses for the ACCEL and Move On When Ready (MOWR) dual enrollment programs. As described in State Board of Education Rule 160-4-2-.20, a 4 added as the fifth numerical digit to the right of the decimal in the high school course number indicates that students receive credit for the course while taking it for dual enrollment credit at an approved postsecondary public or private institution.

• In addition, the use of the 4 as the fifth numerical digit to the right of the decimal in the high school course number will differentiate between high school and postsecondary courses that appear to be duplicates. Duplicate course numbers can be utilized as long as the same course numbers are not used within the same semester for block schedules or the same year for year-long schedules. The words "Dual Enrollment" should be added at the beginning of the title of the course to distinguish between the high school and postsecondary courses. This applies **only** to the core courses on the Accel and MOWR course lists. *Schools are allowed to accept duplicate courses through dual enrollment but all duplicate courses should only be transcribed as elective high school credit.*

- Dual enrollment is not available for summer school.
- Students are limited to 4 units of credit per semester and 8 units per year for dual credit participation.
- Students can earn a total of 8 units per year regardless of the combination of high school and college courses they take.

Beginning this fall, the Georgia Student Finance Commission (GSFC) has enacted several changes in the funding portion of the ACCEL program.

- Students can take unlimited semesters through ACCEL at a post-secondary institution. The postsecondary school still has requirements for admission so someone would need to contact the postsecondary school to determine these requirements (especially for incoming 9th graders).
- Georgia Student Finance Commission is no longer paying a portion of the book fees.
- Georgia Student Finance Commission is no longer paying a portion of the post-secondary's mandatory fees.

Senate Bill 289 directs the state Board of Education to "maximize the number of students" who use digital learning to complete high school coursework in some way shape or form. This effort to maximize participation will begin with students entering the 9th grade during the 2014-2015 school year. In addition, all end-of-course examinations will be available online starting the 2015-2016 school year.

Online education is a significant and fast-growing segment of education. Senate Bill 289 was passed on a largely bipartisan basis in an effort to use all available tools to educate Georgia's students and make Georgia a national leader in this growing field.

Thanks to Senate Bill 289, local school districts and parents of Georgia public, private, school students have the opportunity to choose Georgia Virtual School to supply, supplement, and enhance learning experiences for **ALL** students thought our state.

Student Stories:

1. Student in Chatham County has single parent household, and parent is getting deployed in August for ten months. Daughter is able to maintain Ga residency, move to central Georgia to live with distant relative, take GaVS classes, and return to her home high school next school year when mom returns from deployment. Teen daughter is not forced to transition to new face-to-face high school because GaVS exists.

2. We have a few others who will go with their parents on deployment this fall, maintain Ga residency, and continue education with GaVS while in another country.

Parents are most appreciative in these situations because their children are their top priority. When brief deployments cause teens to be uprooted, parents and students get apprehensive. GaVS offers an option for students!

Teacher Stories:

Our Georgia Virtual School AP Biology teacher, Laela Mitchell, was accepted with a scholarship to the National Association of Biology Teachers/BSCS AP Biology Leadership Academy. She attended a week long training in June and will participate in the NABT conference this fall. The leadership academy requires a two year commitment so she will be attending next year as well.

GaDOE's Statewide Longitudinal Data System (SLDS)




The SLDS is designed to improve instruction by bringing student data to the teacher's desktop through a district's Student Information System (SIS). As of July 10th, all but two school systems in the state have access to the SLDS information through their SIS, most teachers are just one click away from accessing 5+ years of Historical data on their students. In essence, the SLDS is a student's permanent records folder in digital form.

The 2012 CRCT results are PRELIMINARY data and will be overwritten within the next couple of weeks with OFFICIAL results. The State comparisons have been temporarily removed from the LDS Charts. The State comparisons will return when the 2012 CRCT results become official and final, which we anticipate sometime around the first week of July.
