BRUCE BALDWIN, O.D., a graduate of UAB School of Optometry, is a 28 year veteran of the US Air Force where he served in a number of roles including clinician, researcher and educator. His contact lens and refractive surgery research led to the approval of contact lenses and laser vision correction for Air Force Pilots. Dr. Baldwin has taught the art and science of contact lens fitting to optometry and ophthalmology residents at Wilford Hall Medical Center, the UAB School of Optometry, and the USAF School of Aerospace Medicine. Now practicing in North Carolina, Dr. Baldwin manages the UNC Chapel Hill Contact Lens Clinic, offering evaluations and prescriptions for all contact needs, including specialty medical fits for conditions like keratoconus, corneal transplants, and corneal trauma.

LINDA CASSER, O.D., a 1978 graduate of the Indiana University School of Optometry completed a two-year residency program at the Joseph C. Wilson Health Center in Rochester, NY. She served four yeas as Chief of Primary Care Module 4 at the Eye Institute and Assistant at PCO. She was a faculty member at the Indiana University School of Optometry for thirteen years.
