Linda Dunikoski is a Senior Assistant District Attorney and head of the Appellate Section in the Cobb County District Attorney's Office in Marietta, Georgia. Recently she was the lead prosecutor in the <u>State v. McMichael</u> et al, the case involving the murder of Ahmaud Arbery in Brunswick, Georgia. ## Find the Story, Win the Case

Kentucky prosecutors Tom Lockridge and Rewa Zakharia bring an innovative program on the power of story and the importance of delivering a winning opening statement. In this presentation they discuss research into the power of story in both oral presentation to a jury and in written briefs to Judges. The presenters take a deep dive into Hollywood storytelling techniques and reveal the structure of a good story, then apply that structure to a criminal case. The presenters discuss the importance of finding the true emotional story of the case and describe ways to create empathy for the characters in the story (the victims and/or the investigators.) Additionally, the presenters will discuss ways to find the theme of the case based on universal values that will resonate with the jury. The presentation will establish the structure of a good opening statement and provide examples and techniques for effective and persuasive delivery of the opening statement. It is important to inoculate the opening statement to the tactics of the defense and the presenters will offer specific techniques to ensure that the defense cannot overcome the power of the prosecution opening. Finally, the presentation ends with video demonstrations of Opening Statements utilizing the skills taught.
