Board of Examiner News

Effective beginning October 6, 2014, the Drug Enforcement Administration (DEA) has rescheduled hydrocodone combination products from schedule III to schedule II. South Carolina optometrists cannot purchase, possess, administer, supply or prescribe schedule II controlled substances. The South Carolina Board of Examiners in Optometry is currently reviewing ways to address it.

CHANGE IN LICENSE RENEWAL DUE DATE. The due date to renew your optometry license is December 31, 2014. If your license was obtained in 2014 the renewal due date is December 31, 2016.

News You Can Use

Why am I being Audited for Use Tax?

Most individuals and businesses are well versed in the South Carolina Sales Tax, and the related add on taxes by various counties and municipalities for sales/purchases occuring within the state. A lesser known tax is the use tax which applies to purchases of tangible personal property from outside the state. This tax also applies if you lease tangible personal property from outside of South Carolina. Basically, the use tax picks up where the sales tax leaves off, preventing the avoidance of sales tax by purchasing items from outside the state.

How to know if you have a Use Tax liability:

Have you purchased furniture of equipment for your office from a catalogue, an internet site, or leased this type of property from a vendor in another state? If the answer is yes, and you did not remit sales tax to the person or company selling you the property, you owe South Carolina Use Tax on the purchase or lease. This applies to computer software as well. Even though software is not tangible, it is subject to use tax, so check to see if you purchased software from an out of state vendor.

Paying Use Tax:

Use tax is generally paid on form SC1040 by individual taxpayers. Businesses generally pay use tax on their monthly or quarterly sales tax filing with South Carolina Department of Revenue.

Exemptions:

There are many exemptions to the use tax, just as there are for sales tax. Too many to begin listing here actually, SC Department of Revenue has a complete list of exemptions categorized by individuals and businesses.

Dangers:

You do not think about this issue, you continue doing business and going about what you do, remitting only sales tax. One day you get a notice that the SC Department of Revenue wants to audit your sales tax returns, no worries, right? While they are working on that aspect of the audit, they will ask you for your cash disbursements for the past three years. They will focus on payments to vendors with out-of-state addresses and drill down to the purpose of the payment. From there they will total up all payments made to acquire any of the above mentioned properties, determine if you are eligible for exemptions, and if not, hand you a bill. The bill will be 6% plus any of the local taxes that apply; only this will be for the purchases for the thirty six months. Then they add penalty, and interest.

It is not unusual for use tax assessments to be five and six figure amounts. Do not take this lightly. Run a report from your accounting program that shows all of your purchases from out-of-state vendors. Most software will allow you to sort for this. With this information, look at your invoices from the vendors.

Worried? You should be! In our world of online buying, this is an area of poor compliance, and the SC Department of Revenue knows it. Don't be easy pickings for the auditor when they knock.

SCOPA Member's Voice Heard

Last year, the membership committee sent out a SCOPA/AOA Membership Feedback survey to all members of the Association. We received great feedback and wanted to share with the membership in this section of the newsletter. The responses to the feedback are given by the SCOPA's board of directors (SCOPA BOD).

• Member: Have CE meetings outside of peak business cycles.

SCOPA BOD: Unfortunately, this is one of those no-win situations. There are several reasons that the specific time of year is chosen for the Annual Meeting from both the SCOPA and the hospitality industry. One of the first reasons is the SCOPA tries to avoid having meetings close to other large meetings that members enjoy going to, some of which include SECO, Optometry's Meeting, Vision Expo East, etc. Another reason, outside of these peak business cycles coincides with the hotel industry's high-cost times during the year and vice-versa. If we had our meetings outside of our peak business cycles, we also run into the busiest time for hotels and hotel rates of several hundred more dollars per night. With many ODs already concerned with annual meeting expenses, we aim to keep our annual meeting registration and guest room fees as low as possible. In the past the SCOPA has surveyed membership and looked into changing dates around many times. The SCOPA Annual meeting for example, used to be in December at the beach. Membership asked that this meeting be moved to warmer months so the meeting was moved to August.

• Member: Better communication with members on direction, benefits and future plans for SCOPA.

SCOPA BOD: The direction and future plans for SCOPA are discussed at the Board of Directors meetings on the 3rd Wednesday of each month. All active SCOPA members are always encouraged to attend these meetings. Also, the SCOPA Business Meeting held at the Annual Meeting each year discusses any major future plans, changes, the direction the Association is going and any new benefits. A financial presentation is also given, as well as elections (and nominations if needed) for the upcoming leadership year. All voting for changes to the Constitution and Bylaws is only done at the business meeting. The business meeting is one of the biggest and best places to have your voice heard as a member. It not only allows you to have your voice heard by the upcoming leadership, but membership as a whole. During the Annual Meeting, the SCOPA's president-elect has his annual planning board meeting. The president-elect puts together the invitation list, if anyone is ever interested in attending a planning board meeting all they need to do is mention it to the president-elect. The SCOPA always searches for information regarding the latest news as it affects on our profession to update membership. As far as benefits, the SCOPA constantly sends out e-mail blasts and information in the newsletter/e-newsletter if any new benefits have been adopted or are being looked into. The SCOPA typically surveys membership about a specific topic to gather feedback before researching, considering and moving forward with any new member benefits.

Due to the vast amount of feedback we received from members, we are not able to address every comment at one time. We will continue to address the questions and concerns of our members in upcoming issues of the Delineator or SCOPA e-newsletter.
