Changes to AOA Bylaws



As you may already know, significant changes were made to the <u>AOA Bylaws</u> in June during the 115th House of Delegates regarding specific membership classifications. Any members classified as special class, partial practice, and active on the descending dues schedule will be impacted by these changes.

Effective January 1, 2013:

- The special class classification has been eliminated.
- Partial practice eligibility has been changed. To qualify, members must work 16 hours or less per week. This means that those who are currently assessed at 60%, working 3 days or 24 hours per week, no longer qualify for partial practice.
- The descending dues schedule has been eliminated.

Also, as a result of the Bylaws changes, the annual dues assessed for several classifications will also increase.

Effective January 1, 2013:

- Retired members with benefits will be assessed \$100 annual AOA dues.
- Retired members without benefits (in name only) new classification will not be assessed annual AOA dues.
- Partial practice members will be assessed 60% of full AOA annual dues. The graduated scale for partial practice dues has been eliminated.
- Post-graduate members will be assessed \$35 annual AOA dues.

If you have any questions about any of these changes impacting your AOA membership, please do not hesistate to contact the SCOPA office. Again, these are changes that will be effective January 1, 2013 regarding AOA membership.

Tax Deductibility Percentages:

AOA

Contributions or gifts to the AOA are not tax deductible as charitable contributions for income tax puposes. However, they may be tax deductible as ordinary and necessary business expenses, subject to restrictions imposed as a result of association lobbying activities. Ther AOA estimates that the non-deductible portion of your AOA 2013 dues - the portion that is allocable to lobbying - is 9.50%.

SCOPA

Contributions or gifts to the SCOPA are not tax deductible as charitable contributions for income tax puposes. They may be tax deductible, however, as ordinary and necessary business expenses, subject to restrictions imposed as a result of association lobbying activities. The non-deductible portion of your 2013 SCOPA annual dues - the portion that is allocable to lobbying - is 30%.



What Is ORA All About?

The Optometric Recognition Award is designed to recognize and stimulate doctors of optometry in their continuing education efforts with the objectives of maintaining and improving the quality of optometric care.

The initial award requirements are the satisfactory completion of 150 credit hours of continuing education over the three consecutive year period prior to the award year. However, the award requirements may be completed in less time. Transcript quality courses offered by an accredited institution of higher learning will be given double credit hours for ORA purposes upon succesful completion of the course and exam. Verification from the provider is required.

The enrollment fee is \$40 to cover direct costs for the ORA Award Certificate and office procedures.

Five categories, designed to cover a variety of learning experiences, are approved for the Award.

CATEGORY 1	requires a minimum of 90 hours for courses taken from AOA Approved Providers. All 150 hours may be taken in Category 1.
CATEGORY 2	is for courses taken from non-approved providers (that is, not on the AOA list of Approved Providers), and has a maximum limit of 30 hours for the three years.
CATEGORY 3	is for optometric formal and informal teaching; limit - 30 hours.
CATEGORY 4	is for writing and presenting papers, publications, books and lectures; limit - 25 hours.
CATEGORY 5	is for non-supervised individual optometric continuing education; limit - 25 hours.

All enrollees will receive a record-keeping form that is easy to use in logging their hours.

When 150 or more hours have been accumulated and all requirements met, upon submitting the Award Request Form, you will receive an ORA Award Certificate, suitable for display. A Recognition Ceremony is held annually at Optometry's Meeting House of Delegates.

All qualifiers may continue in the program on a year-to-year basis for \$20 each year.

Participation in the ORA program will help you in meeting the challenge of the growing need to provide quality vision care for your patients.
