The Lectures

Dr. Blair Lonsberry

Diagnosing and Managing Ocular Urgencies and Emergencies (33291-PD) Utilizing the latest in interactive technology, this course will review the various presentations of ocular urgencies and emergencies; focusing on triaging, case history and key points in diagnosing various emergent conditions. Appropriate treatment and management plans will be discussed in detail, focusing on current therapeutic intervention.

Eyelid Lumps and Bumps (32376-AS)

Patients' present with a variety of lumps and bumps associated with the ocular and periocular tissues. This interactive presentation will review the various periocular lesions focusing on differentiating the benign from the malignant, the various differentials and current treatment/management options.

Keeping the Macula Dry and the Cornea Wet (36243-GO)

Course will discuss research (ours and others) into both topics and advise the clinician on the latest evidence for management of both problems.

Dr. Greg Caldwell.....

Anterior and Posterior Case Studies (32863-GO)

This course reviews common to complex anomalies of the anterior and posterior segment in case format. This course will include numerous pathologies pertinent to primary care optometric practice and provide clinicians with pearls, therapeutic options and guidance around pitfalls.

Glaucoma Update (31086-GL)

An overview of glaucoma; risk factors (development and progression), disc hemorrhages, the impacts of pharmaceutical agents, target IOP, surgical updates and important goals of therapy will be discussed. The course will emphasize clinical pearls for the primary care optometric physician and will provide clinicians with guidance around pitfalls. Case presentations will be the chief format used during this course.






Dr. Blair Lonsberry was named the Clinic Director of Pacific University's Portland vision clinic in 2005. Prior to joining Pacific University he was an assistant professor at Southern College of Optometry where he was the instructor for Anterior Segment Disease courses and named Teacher of the Year for 6 years in a row. Dr. Lonsberry was also employed as an optometric physician at a vitreoretinal surgery and low vision rehabilitation practice. Dr. Lonsberry is a Fellow in the American Academy of Optometry.

Dr. John Herman: is a native of Pittsfield, MA, where

he currently practices. He is a U.S. Air Force veteran, serving in the Far East during the Viet Nam conflict. He is a graduate of the New England College of Optometry in 1973, where he won 4 clinical awards during his last two years of education. He is a fellow of the American Academy of Optometry, and has achieved its Contact Lens Diplomate Award (one of seven to be so designated in Massachusetts, 157 in the world). He is licensed to practice optometry in Massachusetts, and is certified in both diagnostic and therapeutic pharmaceuticals.





Dr. Greg Caldwell is a 1995 graduate of the Pennsylvania College of Optometry. He is a fellow of the American Academy of Optometry and a Diplomate of the American Board of Optometry. He currently works in Duncansville and Johnstown, PA as an ocular disease consultant. Dr. Caldwell's primary focus is the diagnosis and management of anterior and posterior segment ocular disease. Dr. Caldwell has been a participant in multiple FDA investigations and has lectured locally, nationally and internationally. He is a member of the Third Party Center Executive Committee

for the American Optometric Association. He was President of the Board of Directors for the Pennsylvania Optometric Association in 2010 and currently is a member and chair of various committees.
