President's Message

"How important is membership? Most would say it tops the list of priorities for SCOPA/AOA."

In the past two decades, Optometry has become the Primary Eyecare Profession. This only happened though strong membership in the AOA and the state affiliates. The last decade has been great for optometry. Optometry will continue to face battles like becoming recognized as physicians under Medicaid. There will be issues with discrimination by insurance companies against optometry. If major health care legislation passes, there will be years of interpreting/implementing the 2,000 page law.

It is only through a strong association that the best outcomes to the above and other issues will occur. The more members SCOPA has the stronger its voice in speaking out for all optometrists and the patients we serve. We can be proud that SCOPA has a higher than average membership. Out of 447 practicing OD's in SC, 330 are SCOPA members, a 74% membership. Fourteen states have higher percentage membership.

With a little effort, SCOPA could move way up this list, maybe even have the highest % membership in the US. We will need 74 more members. If only 1/3 of the current SCOPA members recruited another member we would be at 100%.

To make it even easier, SCOPA is offering an amnesty period for previous members (See Page 2). Please consider making a phone call to another OD in SC and invite them to lunch and talk about the benefits of membership.

If you are interested in helping to grow our membership by one, please give me, the SCOPA office, Melissa Schwebach (your SCOPA Membership Trustee), any SCOPA Board member, or your Local Society President a call. We will be glad to provide you with a list of OD's in SC who are not members of SCOPA. MCOs Contract Changes for Vision Services - April 1st Deadline

Update from Dr. Philip Flynn, SCOPA Third Party Chairman

Jackie Rivers and I attended a MCO/MHN Health Plan Meeting on March 4th at DHHS. During this meeting, I had an opportunity to share some of the issues and concerns regarding the upcoming April 1 deadline regarding vision services. I was very encouraged by the response of the committee and the commitment of Medicaid and the MCOs to address proactively our issues in the coming weeks.

We were invited by Medicaid to have another meeting with the MCOs to discuss our concerns in more detail. This meeting has been scheduled and we look forward to the opportunity. In preparation, they have requested that I put together both specific examples and a summary of our issues. Based on feedback thus far, the issues stem from access, reimbursement (not all of the MCOs will reimburse at the same rate) and parity. If there are other issues of importance or concern that you would like expressed, please let me know. Once I've completed the summary, it will be distributed to ensure all issues that are important to the SCOPA membership are addressed by the MCO's. Again, Medicaid and the MCOs are very eager to work with us so that issues can be identified and addressed proactively prior to the April 1 deadline. Having said this, the April 1 deadline is still in place. There have been questions from members as to what changes will take place after April 1. For a patient enrolled only in Medicaid, nothing has changed. The examination will continued to be submitted to Medicaid for reimbursement and if glasses are indicated then they should be sent to Robertson Optical. If a patient is enrolled in a Medicaid MCO, then the examination and vision services should be filled directly to the MCO and not to Medicaid. This will also be true for medical claims. To reiterate, if you are already

enrolled with the MCOs, no other action is needed. If you are not already enrolled, you will need to review the plans and decide now about in which you would like to enroll. Enrolling in the MCO's is each individual's decision. An optometrist may enroll in whichever of the MCO's they decide. An optometrist may enroll in all the MCO's or none of them. While we convey our association's concerns to both Medicaid and the MCO's, now is the time to enroll into the plans if that is what you decide. Please remember to review the participating provider agreement when you enroll and if there are any issues with which you may not agree with; such as reimbursement, you always have the option to discuss and possibly negotiate a more amenable solution with that plan. We did learn that in the very near future, there will only be four Managed Care Plans offered. They will be as follows: Absolute Total Care, Unison Health Plan, Select Health and Blue Choice. Carolina Crescent and SC Solutions will be acquired by one of the four remaining plans. We will share more information with you on this as it is available.

Senate Bill Increases Access To Eye and Vision Care for West Virginians

West Virginia Senate Bill 230 Passed in Senate

Charleston, WV – Thanks to the state Senate, the citizens of West Virginia are one step closer to enjoying better access to eye and vision care. On February 23rd, the state Senate passed S. 230. This bill provides greater access to safe and effective, quality eye and vision care from their local doctor of optometry.

"It's all about access," Sen. Ed Bowman (D-Hancock) said. "With nearly 300 doctors of optometry across the state in 50 of 55 counties, this bill will make it easier for our residents to have high quality eye care."

Senate Bill 230 would confirm the ability of optometrists in West Virginia to perform certain routine surgical procedures. This would ensure that patients will enjoy greater, easier – and often more cost-effective – access to the latest in quality eye care. This will also clarify optometrists' surgical and prescriptive authorities and affirm their ability to safely and effectively perform certain common procedures commensurate with their education and training.

"We look forward to working on this piece of legislation in the House," said Delegate Randy Swartzmiller (D-Brooke County). "This bill not only increases the number of quality providers, it will decrease the distance many of our residents will have to travel for medical procedures."

Doctors of optometry undergo extensive education and training that makes them well qualified to provide comprehensive eye health care, including performing minor surgical procedures. Optometrists complete a four-year, post-graduate, doctoral study concentrating on the eye, vision system and associated systemic diseases. Additionally, optometrists must undergo continuing education to stay current on care.

The bill is now awaiting the signature of the governor.

SC Legislators Delay Driver Vision Test Discussion

South Carolina legislators have delayed discussion of a bill doing away with a requirement for driver's license vision tests every five years. The House's transportation subcommittee said Wednesday it will discuss later requiring vision tests for drivers under age 65 only when they renew their licenses every 10 years. The state adopted a 10-year license renewal system in 2003 but still required drivers to submit to vision tests every five years and imposed a \$50 fine for drivers who didn't comply. The Department of Motor Vehicles says it has not enforced that requirement and no one is complying with it. Drivers 65 and older renew licenses every five years and must prove their vision is good.

- Qualify for the federal American Recovery and Reinvestment Act (ARRA) incentive program, which begins January 1, 2011
- Become part of the U.S. Department of Health & Human Services' (HHS) Nationwide Health Information Network (NHIN) scheduled for launch in 2014, and
- Avoid Medicare payment penalties for practitioners who do not use EHRs, beginning in 2015.
